The sole question is whether each Judge shall be retained in his present office."</p>	<p align="center">CITY OF TOLUCA QUESTION</p> <p>QUESTION: Shall the maximum rate at which the City of Toluca may levy a police protection tax under Sections 11-1-3 and 11-1-5.1 of the Illinois Municipal Code be increased from .075% to .60% of the value, as equalized or assessed by the Illinois Department of Revenue, of all taxable property in the City, beginning with tax year 2018 (payable 2019)?</p> <p><input type="radio"/> YES</p> <p><input type="radio"/> NO</p> <p>EXPLANATION: Section 11-1-3 of the Illinois Municipal Code authorizes non home rule municipalities to levy a police protection tax at the rate of .075 of the taxable real estate within the City. Section 11-1-5.1 authorizes an increase of that rate to .60 percent with referendum approval. If the question passes the referendum, the Toluca City Council will have the authority to levy a police protection tax at the rate of .60 of taxable real estate within the City beginning with tax year 2018 (payable 2019).</p>
